Office Order No. 38/2022

The President of India is pleased to order that the officers of the Indian Revenue Service (Customs & Indirect Taxes) mentioned in the **Annexure** be promoted to the grade of Joint Commissioner of Customs & Indirect Taxes [in the pre-revised pay scale of Pay Band – 3 with Grade Pay of Rs. 7600/-] on ad-hoc basis with effect from the date of assumption of charge of the post and until further orders.

2. The promotion of the officers (whose names are mentioned in the Annexure) to the grade of Joint Commissioner of Customs and Indirect Taxes shall be on '*as is where is*' basis till regular postings are made with the approval of the Competent Authority. Therefore, the officers being promoted through this Order shall assume the charge of the post of the Joint Commissioner in the same office where they are currently posted.
3. The promotion of the officers (whose names are mentioned in the Annexure) to the grade of Joint Commissioner of Customs and Central Excise is purely on ad-hoc basis, subject to the orders for regular promotion by the competent authority based on the recommendations of the DPC for regular promotion.
4. The names appearing in the Annexure are not in order of their seniority and also that the concerned officers will have no right to claim for regular promotion at a later stage when the regular promotion is made.
5. The ad-hoc promotion of the officers (mentioned in the Annexure) to the grade of Joint Commissioner of Customs and Indirect Taxes shall not confer any right on the officers so promoted, for any claim for a regular promotion in the grade of Joint Commissioner and the period of such service will not count for seniority or as qualifying service for further promotions.
6. The ad-hoc promotions of officers (mentioned in Annexure) to the grade of Joint Commissioner are subject to related court cases if any.

7. The concerned Principal Chief Commissioners / Principal Directors General / Chief Commissioners / Director Generals / Principal Commissioners / Principal Additional Director General, CBIC shall ensure that if any of the officers whose names figure in the Annexure to this order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Joint Commissioner and this fact should be reported to the Board immediately. Further, if any of the officers figuring in the Annexure is undergoing any penalty, he/she should be allowed to assume the charge of the post of Joint Commissioner of Customs & Indirect Taxes only after the expiry of the currency of the penalty period. This fact may also be reported to the Board.

8. The compliance report regarding the joining of the above officers shall be sent to the Board [with a copy endorsed to ADG (HRM-II), DGHRD] by 18th April, 2022.
